Below is a coupon for a company called "Slip Grip." They make mounts for almost any GPS, Cell Phone, Tablet, etc to allow them to be mounted on a car or motorcycle.

It does not matter how obscure or unique the device, they will find a mount for you and they are relatively inexpensive (\$20-\$30) including Ram ball mounts etc.

I called them and wanted a Ram 1 inch ball mount attached to a case for my Samsung Galaxy Note 2 that could be used with the Samsung kick stand hard case and they actually came up with one.

Coping with Winter and Wind Chill

Kinda like a chocolate lab with her snout out the window of a pick-up, Daisy never gets tired of her nose in the wind. As winter begins to invade southeastern Michigan in earnest, I feel the same way. No, I don't stick my muzzle out the window when I drive, but it sure is difficult to put the motorcycles into storage. Still got the fever. Still wanna ride.

Granted, the pace slows a bit as cold pavement and moderately warm tires do not sanction aggressive riding - but that's fine. It's more important to be comfortable and enjoy yourself. Despite not yet feeling the need to don heated clothing, I typically have no issue riding in high 30° temperatures. That is, except for my fingers. I've tried many different gloves plus combinations of liners and outer shells but still, after about 30 minutes, my arthritis plagued digits are destined for disintegration. A couple friends, thoroughly sold on the improvement handguards made to their machines, encouraged me to consider them for my BMW.

As luck would have it, my buddy Dan had no use for an unused pair of guards from an older GS (figure 1) so I began work with these. No such product is designed specifically for a R1100SP so the challenge was to construct brackets to position the guards in an acceptable location while maintaining full steering travel and avoiding contact with body panels.

I'll spare you the infinite and tedious steps of positioning both guards with cardboard brackets in search of a suitable position. However, during this process I began to think, "If I want REALLY warm hands, why not ensure protection from the airflow as much as possible." That explains the extra parts in figure 2. These two additional deflectors direct the oncoming wind flow over the top and around the side of the open guard.

All four deflectors, (2) for each hand, began life as a cardboard template. The white object in figure 3 was created for the LH upper deflector. Each outline was transferred to a piece of flat, 1/8" thick ABS plastic and cut to size. Now, the parts required bending and shaping to fit the original guard and ensure adequate hand coverage.

Each end deflector (LH shown in figure 4) was formed over a sphere to produce a cup shape. I've heat-formed a myriad of parts over the years and typically use a small propane torch. A needle nozzle (figure 5) yields a flame for small, precise work or if you need to soften a narrow strip for a simple bend. The fan nozzle, affixed to the torch in the photo, spreads heat over a larger area for complex forming. Once soft, the part can be laid over a rigid object and/or massaged by hand with protective gloves. Figure 4 presents the back of the formed, trimmed and drilled LH end deflector ready for assembly to the guard.

Each guard also requires three new, custom fabricated metal parts; (2) brackets (figure 6) and one plate. I prefer to make these components from aluminum or stainless steel to resist corrosion and permit a high polish. The black bracket clamps around the top of the fork tube in figure 7. A 1 mm thick strip of protective vinyl lines the inside of this aluminum bracket so as not to scratch the

tube.

Figure 8 shows the brackets and plate for the RH side. Each longer bracket was made from 1/8" thick by 1" wide aluminum strip stock. The handguard assembly bolts directly to this bracket.

Figure 9 displays the inside of the left guard with both additional ABS deflectors bolted in place. The triangle shaped plate attaches directly to the plastic guard through existing holes.

The cardboard mock-up phase revealed I would need a thick spacer between the inside of the guard and the end of the handlebar. I used (3) white ¼" thick nylon washers secured with black electrical tape to easily and quickly create this shim. (Figure 11) The stock bar ends were not retained but will be re-installed in the spring when the handguards are removed.

So, was it worth the effort? Absolutely. They REALLY work! Cruising in mid-30° temps for an afternoon including about 40 freeway miles; my fingers were merely cool but not cold. I wore winter, insulated, long gauntlet riding gloves with the heated grips on low.

Of course, the SP must enter hibernation when winter arrives in full force but until then, these modified handguards have opened my comfortable riding window a little more.

Gotta go. The fever's back.

PROPOSED AMENDMENT TO THE MOTOR CITY BEEMERS BYLAWS

At the December 2012 meeting, there was a discussion regarding an increase in dues along with the addition of a small fee for all special events. It was determined that these changes would require an amendment to the Bylaws. As defined in the current Bylaws, any such change requires must be published in the newsletter and then discussed at the next meeting before a vote can be called.

Listed below is the Proposed Amendment:

Annual dues of ~~\$10.00~~ **(\$15.00)** for an individual Regular membership shall be for the calendar year from January to January. Associate membership(s) are available for family members and significant others of regular members ~~at 50% \$10.00. of the regular membership, the current associate membership rate being \$5.~~ All dues are to be collected by January 31 of each year. Unpaid members shall not have a vote at meetings or enjoy other club benefits until such time as dues are paid.

There will be a \$5.00 participation fee for all special events that are sponsored by the MC Beemers; these events currently included the Frankenmuth Chicken Dinner Ride and the Summer Steak Fry.

Members have the right to one (1) vote, hold office and enjoy all other club benefits.

This proposed amendment will be reviewed and voted at the January meeting. The current Bylaws are included on the next two pages for reference.

By-Laws
of the
Motor City Beemers Motorcycle Club

Article 1) The Organization shall be known as the Motor City Beemers

Article 2) The purpose of the organization shall be to pursue, promote, and protect the interests of BMW motorcyclists. To develop better and more enthusiastic relations with the general public and the operators and riders of all motorcycles.

Article 3) The officers of the organization shall be a President, 1st Vice President-Events Coordinator, 2nd Vice President-Ride Coordinator, Treasurer, Newsletter Editor and Webmaster.

The duties of the President shall be:

- To preside at all meetings of the organization
- To have general supervision of the affairs of the organization
- To appoint any person of committee not otherwise ordered by the organization
- To personally represent the organization on proper occasions and business contacts
- To assist all other officers of the organization with their duties.

The duties of the 1st Vice President-Events Coordinator shall be:

- To assist the president with his duties
- To preside in the presidents absence
- Organize and coordinate activities of the club events.

The duties of the 2nd Vice President -Ride Coordinator shall be:

- To assist the president with his duties
- To preside in the Presidents & 1st Vice Presidents absence
- Encourage & work with volunteers to organize rides following the regular monthly meetings and other scheduled club rides.

The duties of the Treasurer shall be:

- To collect dues from all members.
- To collect all other money due the organization.
- To maintain organization financial records and deliver reports.
- To pay financial obligations on a timely basis.
- To maintain E-Group membership.
- Maintain MOA & RA membership status

The duties of the Newsletter Editor shall be:

- Oversee publication of the monthly newsletter.
- To perform such other duties as generally fall to that office.

The duties of the Webmaster shall be:

- To send out electronic notices of regular or special meetings.

- To maintain club website.
- To maintain E-Group membership.
- To perform such other duties as generally fall to that office.
- Owing to the specialized skills associated with the Webmaster's duties, the Webmaster is not an elected position but rather an "exofficial" member, i.e., they are on the board because they have volunteered for the Webmaster job.

The immediate past president shall serve as advisor to the executive board.

Article 4) The nomination of club officers will be held at the regular club meeting in November. Nominations may be made from members in attendance or if not in attendance, members may make a nomination in writing to the person selected to act as nomination chairperson. Written nominations must be presented to the nomination chair prior to the start of the November meeting. Ballots will be mailed and must be returned to the nomination chair prior to the start of the December meeting. Ballots will be opened and tabulated by the officers at the December meeting under "New Business" and will be done so under the supervision of the membership in attendance. Except that uncontested positions maybe confirmed by show of hands. Candidates receiving the highest number of votes shall be elected to terms of office lasting one (1) year. Terms shall start and end under "New Business" at the January meeting.

Article 5) The club shall be operated by majority vote of the membership at regular meetings. All members in good standing shall have one (1) equal vote. All issues voted on must pass by at least 51% a majority of those present. Club officers shall act as the management and administration of the club and represent the club at formal functions.

Article 6) Membership is open to all persons interested in furthering the purpose of this organization. All members are expected to conduct themselves in accordance with the rules and by-laws of the organization. Failure to do so could be subject to dismissal. Violations will be handled by vote of the membership at there commendation of the club officers.

Article 7) Annual dues of \$10.00 for an individual Regular membership shall be for the calendar year from January to January. Associate membership(s) are available for family members and significant others of regular members at 50% of the regular membership, the current associate membership rate being \$5. All dues are to be collected by January 31 of each year. Unpaid members shall not have a vote at meetings and no or enjoy other club benefits until such time as dues are paid.

Members have the right to one (1) vote, hold office and enjoy all other club benefits.


Article 8) Regular meetings shall be held the second Saturday of each month unless otherwise rescheduled for Holidays and other special occasions. Changes shall be noted in the club newsletter before the meeting date.

Article 9) Any amendment or proposal to change the By-laws shall be submitted to the president, be published in the newsletter and be discussed at a regular meeting before a vote is called.

Article 10) In the event of dissolution of the Motor City Beemers, all funds in the treasury will be donated to a charity selected by the majority vote of the Remaining membership of the club.
